Minutes of Meeting January 13, 2006

Dr. J. Dale Nations, Chairman, called the regular Commission Meeting of January 13 to order at 10:00 a.m. in Room 321, State Land Department Building in Phoenix, Arizona.

Dr. Nations presented Mr. Jones with a certificate of completion of ethics training from the Governor's Office.

Dr. Nations reported that the Governor had re-appointed him to the Commission. Dr. Nation's term expired in January 2006.

APPROVAL OF THE MINUTES OF THE MEETING OF OCTOBER 14, 2005

Mr. Jones moved, seconded by Mr. Lane:

THAT THE MINUTES OF THE MEETING OF OCTOBER 14, 2005 BE ACCEPTED AS PRESENTED

Motion carried unanimously.

REPORT OF THE OIL AND GAS ADMINISTRATOR

The activity report of Mr. Rauzi was sent to the Commissioners and has been made a part of these minutes. Mr. Rauzi reported that a permit was issued to Ultimate Exploration and Development for a hole near Colorado City and that APS completed two temperature gradient holes in the Clifton area.

STATUS OF 2006 SUNSET REVIEW OF THE OIL AND GAS CONSERVATION COMMISSION

Dr. Nations discussed the November 16 hearing of the Interim Committee and the follow-up material prepared by Mr. Rauzi. The Interim Committee voted 9 to 0 to continue the Commission. HB 2098 continues the Commission for 10 years through 2016.

STATUS OF RIDGEWAY ARIZONA OIL CORPORATION WELLS 22-1X STATE (PERMIT 888), 11-21 STATE (PERMIT 895), 10-22 STATE (PERMIT 896), 9-21 STATE (PERMIT 897), 12-15-30 STATE (PERMIT 900), AND 11-18 STATE (PERMIT 916), APACHE COUNTY AND POSSIBLE DECISION CONCERNING REQUEST FOR TEMPORARY ABANDONMENT AND POSSIBLE REPORT OR PRESENTATION BY A REPRESENTATIVE OF RIDGEWAY

Mr. Rauzi reported that Ridgeway submitted a written request to extend temporary abandonment through January 2007. Ms. Woodall asked who authorized Mr. White to write





the request. Mr. Lakser, President and CEO, stated that he authorized Mr. White. Mr. Rauzi recommended extension noting no change in environmental, safety or beneficial use issues from previous extensions except that four wells, permit numbers 895, 897, 900, and 916, were on leases that would expire this month and be subject to a simultaneous filing. He recommended extending temporary abandonment for the four wells if Ridgeway regained the leases or allowing Ridgeway 120 days to plug the wells if Ridgeway did not regain the leases.

Ms. Woodall asked if Ridgeway did not regain the leases would the new lessee allow access to Ridgeway to plug the wells and what about the gap between the expiration of the lease and issuance of the new lease. Mr. Rice responded that the Land Department planned to incorporate language in the new leases to allow Ridgeway access to plug the wells and would allow access during the gap. Mr. Kiehne asked if that would conflict with generally standard lease provisions allowing an operator 180 days to recover equipment from an expired lease. Ms. Woodall indicated Mr. Rice's statements to allow access covered that.

Mr. Wagner moved, seconded by Mr. Jones:

TO EXTEND TEMPORARY ABANDONMENT TO WELLS 22-1X (888) AND 10-22 (896) THROUGH JANUARY 2007

Motion carried unanimously.

Mr. Jones moved, seconded by Mr. Wagner:

TO EXTEND TEMPORARY ABANDONMENT THROUGH JANUARY 2007 TO WELLS 11-21 (895), 9-21 (897), 12-15-30 (900), AND 11-18 (916) IF RIDGEWAY REGAINED THE LEASES IN A DRAWING AS A RESULT OF A SIMULTANEOUS FILING AND TO PLUG THE WELLS WITHIN 180 DAYS OF THE DRAWING IF RIDGEWAY DID NOT REGAIN THE LEASES

Motion carried unanimously.

Ms. Woodall advised Ridgeway that in the event it did not regain the leases and was not able to plug the wells within the 180 days granted in the motion to show factual evidence of its diligent efforts to contract with appropriate companies to plug the wells.

ELECTION OF OFFICERS

In light of Dr. Nation's reappointment, Mr. Wagner moved, seconded by Mr. Jones:

TO CONTINUE THE CURRENT OFFICERS FOR ANOTHER YEAR

After discussion Mr. Lane offered a substitute motion, seconded by Mr. Jones to:

REELECT THE CURRENT OFFICERS FOR A NEW TWO-YEAR TERM

Mr. Wagner withdrew his original motion; Mr. Jones withdrew his original second.

The substitute motion carried unanimously.



Re: Activity Report for the April 28, 2006, Meeting

One permit to drill was issued and one well was drilled since your last meeting on January 13, 2006.

EL Paso Natural Gas Company permitted another stratigraphic well in the Picacho basin to gather additional information relative to subsurface storage of natural gas. El Paso plans to start drilling in late April or early May.

Ultimate Exploration and Development LLC drilled its well southwest of Colorado City to a total depth of 7690 ft in March and April. All information from the Ultimate hole is being held confidential in accordance with statute.

Arizona Public Service (APS) completed two of its three temperature gradient wells they permitted in the Clifton area. APS continues to monitor heat flow in the wells.

The Commission extended temporary abandonment to the Ridgeway 22-1X and 10-22 wells through January 2007. The Commission conditionally extended temporary abandonment to the Ridgeway 11-21, 9-21, 12-15-30 and 11-18 wells through January 2007 depending on whether or not Ridgeway regained its expiring leases. Mr. Tom White of Ridgeway informed me that he would be in attendance to discuss the matter.



AN ACT

REPEALING SECTION 41-3006.03, ARIZONA REVISED STATUTES; AMENDING TITLE 41. CHAPTER 27, ARTICLE 2, ARIZONA REVISED STATUTES, BY ADDING SECTION 41-3016.01; RELATING TO THE OIL AND GAS CONSERVATION COMMISSION.

Be it enacted by the Legislature of the State of Arizona:

Section 1. Repeal

Section 41-3006.03, Arizona Revised Statutes, is repealed.

Sec. 2. Title 41, chapter 27, article 2, Arizona Revised Statutes, is amended by adding section 41-3016.01, to read:

41-3016.01. Oil and gas conservation commission: termination July 1. 2016

- A. THE OIL AND GAS CONSERVATION COMMISSION TERMINATES ON JULY 1, 2016.
- B. TITLE 27, CHAPTER 4, ARTICLE 1 IS REPEALED ON JANUARY 1, 2017.

Sec. 3. Purpose

Pursuant to section 41-2955, subsection B, Arizona Revised Statutes, the legislature continues the oil and gas conservation commission to regulate the drilling for and production of oil, gas, helium and geothermal resources, promote the conservation of these resources, protect their ownership rights, safeguard the public health and otherwise effect the public policy of this state pursuant to section 27-502. Arizona Revised Statutes.

Sec. 4. Retroactivity

Sections 1 and 2 of this act are effective retroactively to July 1, 2006.


