NOTICE OF COMBINED PUBLIC MEETING AND POSSIBLE EXECUTIVE SESSION ARIZONA OIL AND GAS CONSERVATION COMMISSION

Pursuant to A.R.S. § 38-431.02, notice is hereby given to the members of the Arizona Oil and Gas Conservation Commission (OGCC or Commission) and to the general public that the OGCC will hold a meeting open to the public on **February 23, 2018, at approximately 11:00 a.m. in Room 3100B**, third floor of the Arizona Department of Environmental Quality, at 1110 W. Washington St., Phoenix, AZ. This meeting will immediately follow the conclusion of the Ranger Public Hearing that starts at 10:00 a.m.

- 3. Plug and abandonment of the SunCor #1-24 and #1-19:
 - SunBelt Holdings' contests the Commission's requirement to fill both wellbores with plugging mud below the cast iron or steel bridge plug (set at 2,100 ft.± in both wells). SunBelt requests that the Commission reconsider allowing the wells to remain filled with water below the plug.
 - The Commission may discuss, consider and vote to approve, modify or deny SunBelt Holdings' request to grant a variance to A.A.C. R12-7-127(D).
