**NOTICE OF COMBINED PUBLIC MEETING AND POSSIBLE EXECUTIVE SESSION
ARIZONA OIL AND GAS CONSERVATION COMMISSION**

Pursuant to A.R.S. § 38-431.02, notice is hereby given to the members of the Arizona Oil and Gas Conservation Commission (AOGCC or Commission) and to the general public that the AOGCC will hold a meeting open to the public on **July 17, 2020, 1:00 p.m. Note that this meeting will be via electronic means only. 4. Arizona Energy Partners (AEP) 16-1: The TA status was extended to August 13, 2020 by the Commission. AEP is expected to participate in this meeting to make a demonstration of future beneficial use of the 16-1 well, pursuant to AAC R12-7-125(B). A failure to meet the requirements of section 125(B) requires that the well be plugged and abandoned. The Commission may consider and discuss the status of this well and may approve additional time for TA status, or order plug and abandonment.
5. Rare Earth Exploration LLC 12-1 State and 28-1 State: The Administrator notified the operator in a letter dated January 30, 2020 that the AOGCC ordered the plug and abandonment of the 12-1 well on or before May, 1, 2020. The deadline was subsequently extended to July 31, 2020 and the operator also agreed to also P&A the Rare Earth 28-1 State. Repeated attempts to contact the company for a progress report were finally successful on July 10, 2020. As of the publication date of this notice, the Administrator has received no application to plug and abandon the 28-1 State. The Operator has indicated they will participate in this meeting to give an update on their progress towards plug and abandonment as well as future well drilling plans. The Commission may discuss takeover of the performance bond covering both wells to plug and abandon these wells or extend the deadline to P&A.

Members of the Arizona Oil and Gas Conservation Commission will attend in person, by video conference, or by telephone. The public may also attend a Commission meeting in person, by video conference, or by telephone.

The public may be afforded an opportunity to comment on any item on the agenda; however, by ruling of the Arizona Oil and Gas Conservation Commission, any member of the public wishing to speak at this meeting shall be limited to three (3) minutes (see Note 1). Note that agenda items may be taken out of order at the discretion of the Commission.

NOTE 1: Any comments provided by the public at the Call to the Public shall not exceed three (3) minutes per speaker. For any comments made during the Call to the Public on any specific issue the overall comment period shall not exceed ten (10) minutes per side. The Commission shall have the authority to end any public discussion that exceeds ten (10) minutes per side or twenty (20) minutes in total.

NOTE 2: The Arizona Oil and Gas Conservation Commission (Commission) may discuss, consider and vote on any item contained in this agenda. Additionally, the Commission may vote to hold an Executive Session, pursuant to AR.S. § 38-431 .03(A)(3) or (4), which will not be open to the public, to consult with its attorney and receive legal advice with respect to any regular agenda item listed on this agenda.
