RANGER DEVELOPMENT LLC., having filed application and notice of intention to drill one new well on Section 15, Township 14 North, Range 25 East, and re-enter an existing plugged and abandoned well in Section 9, Township 19 North, Range 26 East, Gila and Salt River Base and Meridian and on Gila and Salt River Base and Meridian, location being in Apache County, Arizona, and having requested that an exception be made to Arizona Administrative Code R12-7-107(B) relative to the spacing of gas wells,

- The Commission voted to continue the Hearing for the Ranger Development LLC (Ranger) 15-1 Oso to the next regularly scheduled meeting at 10:00 a.m. on Feb. 23, 2018. Ranger may repeat their justification for the well spacing exception. The Commission may discuss, consider and vote to grant or deny the well spacing exception.
- Ranger proposes to re-enter the Ram Oil Co. 1-9 Hortenstine to test the Shinarump and possibly certain units below. Ranger shall present their justification for this well spacing exception, by virtue of re-entering the well, including any relevant subsurface data. The Commission may discuss, consider and vote to grant or deny the well spacing exception/ re-entry.
- In lieu of approving the well spacing exception for the Ram Oil Co. 1-9 Hortenstine, the Commission may discuss, consider and vote to extend the permit approval to drill the Ranger 9-1 PDS, which expired on January 16, 2018.
