MINUTES OF HEARING
TRIOMPHE ENERGY WELL RECLASSIFICATION and
WELL SPACING EXCEPTION
OCTOBER 26, 2018

CALL TO ORDER

Mr. Thorwald called the AOGCC Public Hearing of October 26, 2018 to order at 10:15 a.m. in Room 3100B at the Arizona Department of Environmental Quality, Phoenix, Arizona.

DISCUSSION and VOTE on TRIOMPHE ENERGY'S WELL RECLASSIFICATION.

Scott Bowles, Geologist for Triomphe Energy, LLC, made a brief presentation and requested the AOGCC reclassify the Triomphe Energy #1 from an oil well to a gas well.

After the Commission discussed the issue, Dr. Nations said the reclassification is justified, based on the test results and geological interpretations and moved, seconded by Mr. Thorwald:

THAT THE RECLASSIFICATION OF THE TRIOMPHE ENERGY #1 WELL BE APPROVED AS SUBMITTED.

The motion passed unanimously 4-0.

DISCUSSION and VOTE on TRIOMPHE ENERGY'S WELL SPACING EXCEPTION.

After the Commission discussed the issue, Dr. Nations said the spacing exception for the Triomphe Energy #1 is justified, based on the geological interpretation and moved, seconded by Mr. Thorwald:

THAT THE SPACING EXCEPTION FOR THE TRIOMPHE ENERGY #1 WELL BE APPROVED AS SUBMITTED.

The motion passed unanimously 4-0.


Mr. Thorwald asked for public comment. No comments were made.
